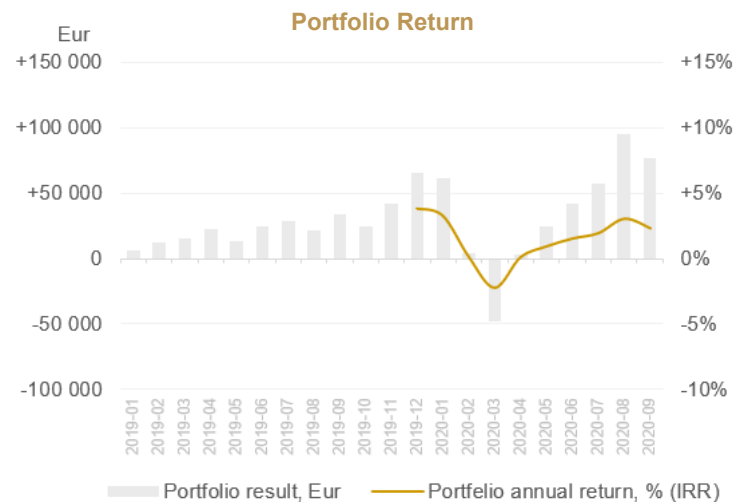
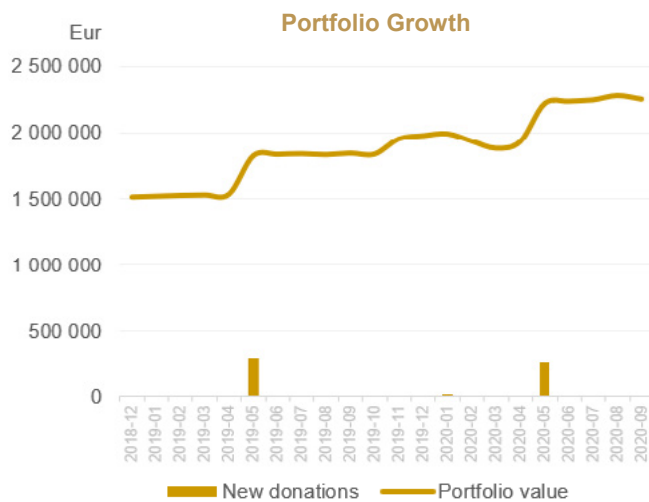

Comment:

"After the global economy shutdown in 2020 Q1, economy conditions in most of the countries have gradually brightened up till the end of 2020 Q3, but further dynamics will highly depend on how the countries will manage to cope with COVID-19 virus. Uncertainty and high volatility will remain until the end of the year until there will be news on vaccine.

We expect that corporate earnings might drop by $\pm 20\%$, this year, but should get back to pre-pandemic levels until the end of 2021. We do not anticipate high inflation risk in the near-term, but rising inflation could be a real threat in longer term.

Given high volatility of capital markets, we will keep well-diversified investment portfolio strategy to be in line with our long-term portfolio investment goals", - comments Alius Jakubėlis, the Chairman of Board of Investments at Vilnius University Foundation.
